PEN OF THREE & SINGLE FEEDER STEER SHOW AND SALE

Entries Close: October 1, 2011

(\$2,000.00 for pens & \$1,000.00 for single) plus ADDED PURSE.

GENERAL RULES

1. This show will consist of a pen of three (3) steer show (Section 0238) and a single steer show (Section 0237). The single steer must come from the pen of three or alternate and must be designated at weigh-in. The designated single steer cannot be switched between weigh-in time and show time except for health reasons which must be approved by the official veterinarian and the show superintendent. Only one single per pen can be entered.
2. One alternate animal may be entered with each pen of three and it must be eartagged and sold with pen of three. No second alternate is permitted. The designated alternate must be declared at weigh-in and it can show in the single class. The designated alternate cannot be changed between weigh-in time and show time except for health reasons which must be approved by the official veterinarian and the show management.
3. Feeder steers (pen and single classes) will be shown by weight and not by breed. They will be divided into three (3) classes by weight. The lower weight limit is 450 pounds and the upper limit is 750 pounds for each steer. The single steers will be weighed individually after each pen of three is weighed and put in appropriate weight classes.
4. The show order will be light, medium, and heavy weight single steers followed by the champions. The pen of three show will follow with the light, medium, heavy, and champion classes.
5. The North American International Screening Committee will inspect and determine those pens that meet the rules and regulations of the show. Entry fee will not be refunded on eliminated pens.
6. Cattle entered in these classes must be pens of merchantable "Feeders" - i.e., free of lump jaw, blindness, no horns (cattle must be properly dehorned and sufficiently healed), evidence of late castration or otherwise unmerchantable cattle. No evidence of ringworm and warts will be allowed. All pens will be inspected by the official veterinarian at the time of weighing and eartagging.

7. Individual health papers will be required on each individual animal and must be turned in to the Superintendent at the time of weighing and eartagging. (See Health Requirements.)
8. **Calves will be ear tagged and weighed for classification between 1:00 p.m. and 4:00 p.m. on Friday, November 11. No reweighs will be permitted. All other eartags will be removed when tagged with the NAILE tag. Eartags must not be tampered with for any reason. If a tag is lost, contact the show superintendent immediately so that it can be replaced.**
9. Feeder steers should be fitted and must be broke to lead. A halter must remain on each calf after the sale.
10. There will be a grooming chute fee of \$35.00 per chute for feeder steer exhibitors.
11. All entries must be tied in their stalls in the designated area of the barn by 12:00 Noon, Friday, November 11, and will not be released from the grounds until after the sale is completed, the cattle paid for, and a release form has been obtained. All feeder calves must be claimed by their new owner by 12:00 noon, Sunday, November 13.
12. Each exhibitor is limited to a total of six (6) pens of three, but can win only two (2) premiums per class.
13. The pens of three will be shown loose, with no halters permitted during the judging of the pens, except to hold steers during final placing and reasons. The single steers will be shown at halter only.
14. **All entries in the actual Feeder Calf Show must be sold at auction as shown including the alternate in each pen.** Each pen will sell by the head at buyer's choice from one to four calves. Selling of that pen will continue on same basis until all calves in entry are sold. After the first 30 pens are sold, each of the remaining pens will be sold as a lot with no choosing. If any entry fails to go through the auction, all premium money will be withheld and the exhibitor will be barred from future entry in this show.
15. All pens eliminated from the show by the committee will be allowed to sell as a lot after the pens in the show have sold. The Superintendent will determine the order of the sale for all outpens.
16. There will be a 10% sale commission charged on all feeder cattle sold.
17. The official veterinarian will check the health and temperature of the steers after the show and before sale time.
18. The Show Management reserves the right to interpret the rules or make any decisions regarding the show and sale deemed necessary in the best interest of the show. The NAILE general rule #24, Code of Ethics, shall apply to this show as well as other general rules that may be applicable.
19. Premiums in each class of the singles and pens of three will be prorated for 1st thru 10th places.

GENERAL RULES

1. This show will consist of a pen of three (3) heifer show (Section 0236) and a single heifer show (Section 0235). The single heifer must come from the pen of three or alternate and must be designated at weigh-in. The designated single heifer cannot be switched between weigh-in time and show time except for health reasons which must be approved by the official veterinarian and the show superintendent. Only one single per pen can be entered.
2. One alternate animal may be entered with each pen of three and it must be eartagged and sold with pen of three. No second alternate is permitted. The designated alternate must be declared at weigh-in and it can show in the single class. The designated alternate cannot be changed between weigh-in time and show time except for health reasons which must be approved by the official veterinarian and the show management.
3. Pen heifers (pen and single classes) will be shown by weight and not by breed. They will be divided into three (3) classes by weight. The lower weight limit is 450 pounds and the upper limit is 750 pounds for each heifer. The single heifers will be weighed individually after each pen of three is weighed and put in appropriate weight classes. All heifers are to be 11 months of age or less.
4. The show order will be light, medium, and heavy weight single heifers followed by the champions. The pen of three show will follow with the light, medium, heavy, and champion classes.
5. The North American International Screening Committee will inspect and determine those pens that meet the rules and regulations of the show. Entry fee will not be refunded on eliminated pens.
6. Cattle entered in these classes must be pens of merchantable "Feeders" - i.e., free of lump jaw, blindness, no horns (cattle must be properly dehorned and sufficiently healed), or otherwise unmerchantable cattle. No evidence of ringworm and warts will be allowed. All pens will be inspected by the official veterinarian at the time of weighing and eartagging.
7. All heifers are to be guaranteed open by the owner/exhibitor. Should any heifer be confirmed to have been pregnant on sale date within 60 days of sale date by a certified veterinarian, it is the sellers' responsibility to make satisfactory restitution with the buyer.

8. Individual health papers will be required on each individual animal and must be turned in to the Superintendent at the time of weighing and eartagging. (See Health Requirements.)
9. **Calves will be ear tagged and weighed for classification between 1:00 p.m. and 4:00 p.m. on Friday, November 11. No reweighs will be permitted. All other eartags will be removed when tagged with the NAILE tag. Eartags must not be tampered with for any reason. If a tag is lost, contact the show superintendent immediately so that it can be replaced.**
10. Pen heifers should be fitted and must be broke to lead. A halter must remain on each calf after the sale.
11. There will be a grooming chute fee of \$35.00 per chute for pen heifer exhibitors.

15. **All entries in the actual Pen Heifer Show must be sold at auction as shown including the alternate in each pen.** Each pen will sell by the head at buyer's choice from one to four calves. Selling of that pen will continue on same basis until all calves in entry are sold. After the first 30 pens are sold, each of the remaining pens will be sold as a lot with no choosing. If any entry fails to go through the auction, all premium money will be withheld and the exhibitor will be barred from future entry in this show.
16. All pens eliminated from the show by the committee will be allowed to sell as a lot after the pens in the show have sold. The Superintendent will determine the order of the sale for all outpens.
17. There will be a 10% sale commission charged on all pen heifers sold.
18. The official veterinarian will check the health and temperature of the heifers after the show and before sale time.
19. The Show Management reserves the right to interpret the rules or make any decisions regarding the show and sale deemed necessary in the best interest of the show. The NAILE general rule #24, Code of Ethics, shall apply to this show as well as other general rules that may be applicable.
20. Premiums in each class of the singles and pens of three will be prorated for 1st thru 10th places.
