CONTESTANT ELIGIBILITY

1. Each state is invited to enter one 4-Her (4-H Team when applicable) for each of the six events offered during the Eastern National 4-H Horse Roundup.
2. Representatives are to be selected by any procedure which a state deems appropriate.
3. Contestants must be at least 14 years of age; they have not yet achieved their 19th birthday on January 1 of the current year.
4. Contestants must be enrolled in 4-H in the state they represent and be certified by the State 4-H Leader or Extension Horse Specialist for participation.
5. Contestants (including team alternates) may participate in only one contest per year at the Roundup. After competing in this contest, they are ineligible to compete in the same specific contest again in future years.
6. Contestants must not have competed previously in a specific contest at the Eastern National 4-H Horse Roundup in Louisville, Kentucky, or the Western National 4-H Horse Classic in Denver, Colorado. Contestants cannot compete in both the Eastern (Nov. 2011) and Western (Jan. 2012) events during the same program year.
7. Contestants may not have participated in any official, post secondary contest (university, college, junior college or technical school) for their respective event (i.e.: horse judging, horse bowl, public speaking, etc.). If a youth is enrolled in college courses please contact appropriate contest contact below.
